

Our home has been deeply disturbed by the flights on the illegal flight paths over our home in Ratoath.

I have lived between Ashbourne and Ratoath over 20yrs and these ever expanding towns were never in the 2007 flight path in the planning of the North Runway.

Our peace in our home has been hugely disturbed, there are very frequent flights right over our house and some are so loud and fly so low we cannot hear each other. They can start as early as 5 am and sometimes during the night right through the day to 11pm.

The flight path was not planned over Ratoath when we bought our home.

Weekends are worse and the summer has been torture.

We have put years of work into our garden and especially in the summer we are unable to go out in the garden and enjoy nature. It is so loud from the continuous stream of planes.

This continuous flow of planes have caused me great distress, in our home while sitting in any room the planes can be heard and the noise is very intrusive, more than anything I have known.

I have needed to attend my GP because of the stress that this has caused me.

This illegal pathway has caused me and my family great emotional and physical distress, I have struggled to sleep, I'm anxious (have never had this before) and so concerned for the future and the effect it is having on my health.
