I have lived in my home for the past 36 years and imagined enjoying by retirement years through additional time in my garden with my grandchildren. Unfortunately since the opening of the new runway and the operation of the illegal flightpaths the quality of my life has been impacted very negatively.

I am woken up by the loud noise and it continues relentlessly throughout the day. This has impacted on my health with an increase of insomnia and consequential anxiety. I am extremely anxious about the proposed increase of night flights as I know this will result in even less sleep than I am managing currently. The extension of day hours from 6am to midnight will also have an adverse impact on possible sleep.

I enjoy gardening and being outdoors as much as possible. However this has become very difficult with the continuous noice of the planes directly overhead. As one plane goes out of sight I can often hear the next one approaching. It is very difficult to engage in conversations, either in person, on the phone or listen to the radio due to the volume pf noice from overhead aircraft. The overall quality of my life has been affected negatively.

I built my house in accordance with planning permission and I am very distressed that a powerful body such as the DAA does not have to adhere

distressed that a powerful body such as the DAA does not have to adhere to what was agreed in 2007. If this crucial issue is addressed than other changes may then be considered.

An oral hearing is absolutely necessary given the gravity of the situation.
