

Ever since the North runway was operational, the DAA have allowed planes to make manoeuvres after take-off over the village of Ratoath, Co. Meath. These planes have been flying directly over my house in direct violation of the original planning permission for the North runway. The noise these plane cause has been hugely disruptive – starting shortly after 6am and going on until nearly midnight (sometimes afterwards). The noise is loud enough to wake us up and is frequent enough to stop us sleeping. I have submitted around 50 complaints to the DAA which have been ignored outside of an automated response. Each of these complaints have been raised for separate incidences but I could have raised 100 times this number of complaints for the number of noisy planes that are flying over my house. The DAA are ignoring the people of Ratoath, ignoring the planning laws and should be held to account.
