I am submitting this observation to request that planning permission be refused to the DAA for the following reasons

Firstly, the applicant is submitting flight paths different to the flight paths originally granted permission. These new flight paths have been in use for the last year – therefore the applicant is applying for retention, which should not be permitted for this type of development.

Secondly, they are asking for an increase in the operating hours of the north runway. I am currently directly flown over every morning by planes departing the north runway at 7am. This awakens my young children also. The World Health organization recommends 10-13hours of sleep for young children. These new operating hours would mean my children would only be able to get six hours of sleep. This is unacceptable for an adult to function well, let alone a young child.

Thirdly they are asking to remove the cap of 65 flights at night for a noise quota system. They have exceeded 65 flights at night for many years. They have acted with disregard for our community and broken planning laws. They simply wish to have a less transparent system in order to continue to break these laws.

I have experienced a year of hell since the opening of the north runway. I ask that the applicant have the same law applied to them as the rest of the country. They have continually broken their current planning. Corporate greed should not be allowed to run the lives of hard working people and their children.
