I would like to make the following observations to An Bord Pleanála so that I can show you my objection to the proposal of development that relates to the use of the runway system at Dublin Airport.

I would like to start by stating that my husband and I built our home at k45w965 in 1998 and although we were well aware that we were building our home in close proximity to Dublin airport, we could never have imagined that we would end up directly under a flight path that has had such a profound effect on our home and work life.

Please read the following points I'm trying to make that will help you to understand our upset and disappointment, along with serious issue with what has been happening.

- 1. My first point that I would like to draw your attention to the fact that absolutely no consultation was made with my family or myself by Dublin Airport, the DAA or the AAI informing us that the new runway would cause so much stress and anxiety and that there would be such a huge increase in aircraft noise over our home. We had no idea that we would find ourselves living directly under a flight path that would be in operation not only in day time but at night also. No one cares about my family and how we are suffering from the aircraft flying over us. How can this be right. We are woken up early morning and late at night because of what's going on. How do they expect us to sleep I have 4 young children that are very much effected by the noise.
- 2. There seems to be no governance by ANCA or FCC to enforce that the DAA stick to their original planning permission that was in place for the new RWY 28R north runway opened on 24th August 2022. It seems these planning conditions are being breached all the time including the exceeded night time flights cap. However I'm aware of the fcc court enforcement case that is being perused. Can I just state the current operations of the north runway bear no Resemblance to current planning permission. Which means there is no regard shown by Dublin Airport.
- 3. We just can't enjoy our home as we did before. My new back garden that cost so much money to develop is now a place where I can not hear the person I'm talking to if I'm on my phone or sitting in the garden. You need to understand the severe impact the noise has brought to our family while out in our front and back garden now. This extends to leaving windows open and having to listen to the loud noise of aircraft climbing in the sky right over what used to be our lovely home.
- 4. Please do not allow any more night time flights.
- 5. Please no not allow increased day time flights.

- 6. The suggestions and now research into the health issues that we are likely to suffer long term are so worrying for us. What should we do sell up & move? That is not an option, even my property value is effected.
- 7. Unlimited night flights using a noise quota is going to make life so much worse for my family and I'm sure my neighbours. A cap must be used so please help us. Unauthorised flight paths are causing severe harm. Please stop them.
