

The present flight paths been used on the new north runway are not the flights paths that were granted planning permission for, aircraft where required to depart and fly further west to gain altitude and then commence flight direction paths, as this is permission has not been adhere to it has caused noise levels in the Oldtown areas to an unacceptable level causing much discomfort to myself and neighbours.

Presently the DAA are limited to 65 flights during nighttime and this condition is broken regularly during the week by as many as 100 flights per night adding to the noise level when people are trying to sleep.

I have resided in Oldtown for over twenty years and have accepted that the airport would always develop, and traffic would increase, however I thought the least that the DAA could do was to adhere to the conditions of planning granted by the council and engage with their neighbours and local communities, there has been no engagement and their system with dealing with complaints is wholly inadequate.

My way and that of my neighbour's way of enjoying our living environment has been completely changed for the worse.

The DAA do not make good neighbours.
