I am asking you to REFUSE PERMISSION to DAA relevant action because where I am living I am finding it hard to go about my daily business with the current noise from the planes overhead. This starts at 6.30am to which wakes me up and will continue every 3 -4 mins. I should not have to deal with this noise every single day. The planes continue to fly over my house at night time as well up until 11.30pm. Where does this stop. It's affecting my family's mental health.

I have looked into this further and have realised that I am actually living directly under an illegal flightpath since the opening of the North Runway. The planning conditions of 2007 show flightpaths that are different to today's flightpaths that are being used by the DAA and is affecting the area in which I built my house. I would have never built here if this flightpath was approved in the 2007 conditions.

The noise of the planes are so loud, that you have to stop a conversation in your own back garden and then continue the conversion after the plane pass but even worse is this will happen every 3-4 mins. Also to be woken up by planes at 6.30am and then trying to sleep at night and being woken up at 11pm by planes....this torture and never ending.

The flightpaths must be made to use the original flightpaths that were was proposed in 2007 and going further there should not be any new proposal of flightpaths until this matter is brought back to the original proposal in 2007.
