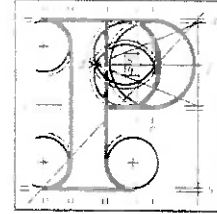

We have reviewed your Response carefully.

Despite appearances, it is neither a substantive nor a complete response to our concerns. Our proposed mitigations were broadly ignored.

Most importantly, we note that the Applicant's diagrams on pages 202- 203 corroborate the truly significant, permanent impact on vehicular access to our family home via the so-called alternative access routes shown.

It seems clear that the NTA deems this impact to be collateral damage in pursuit of the "positive impacts to pedestrians, cyclists and bus users from the Proposed Scheme".

We retract none of our original comment.
