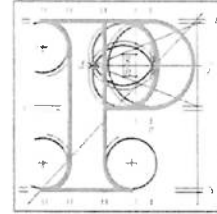

Re Templeogue/Rathfarnham to City Centre Bus Connection Proposal

We wish to object to this scheme in the strongest possible terms.

1. Victoria Road will become a rat run with people ignoring the no turn restrictions at Wasdale Road and most likely Glenayr.
2. Complete lack of clarity about how we get to Rathmines
3. Complete lack of clarity about how we get to/from Templeogue and therefore M50 access.
4. Our bus connect route has the most complex issues as roads are much narrower.
5. No understanding of local traffic issues to our area as no modelling has been carried out.
6. There will be traffic chaos at Rathgar crossroads. This will seriously affect the village atmosphere, will cause local business to fail, therefore putting more cars on local roads as we can no longer walk to local services, as they will not exist. This is both lunacy and environmentally unsound.
7. Terenure Road East will lose all its trees. This is environmentally unsound.
