

Further to my submission last summer 2023, I would like to restate my objection to the Bus Corridor number 12 for the following reasons:

- Rathgar is one of Dublin's loveliest heritage villages, built over 200 years ago. The
 Bus Connects plan of increasing bus traffic will seriously damage the heritage of the
 village, the businesses operating in the village (less car parking for customers) and
 the local community who want to live and do business here. An Bord Pleanala should
 cherish Dublin's heritage villages.
- 2. Since Covid, passengers traveling into work 5 days a week has decreased dramatically. In its plans, Bus Connects used bus passenger modeling from 2016 therefore the plans are pre-Covid numbers which are no longer correct. This modeling is obsolete and does not reflect the level of passengers travelling by bus into offices in 2024.
- 3. The traffic modeling for the Bus Connects plans was completed during the summer months when the road traffic is dramatically reduced and schools are closed. The new plan does not reflect the true volume of traffic on the roads.
- 4. The bus stop near my house number 86 Rathgar Road is totally unsuitable and has been shown in Bus Connects measurements of the bus stop that it allows insufficient space for buses. I do agree with the bus stop moving but suggested a move closer to

the village outside apartment blocks 90-94 Rathgar Road where there is twice as much space for buses to arrive and depart.

- 5. Besides Rathgar, the proposed traffic routes will be detrimental to Rathmines and Ranelagh and to the people living there. The smaller roads will be filled with traffic and will lead to less mobility and quality of life for residents.
- 6. I travel by bus, walk as much as I can and drive an electric car. Clearly, I believe in public transport and protecting the environment but not to the detriment of communities and villages in Dublin. Extending Metro North out to Tallaght with stops in Rathmines, Rathgar, Terenure, Rathfarnham to Tallaght would allow Dublin to look beautiful. There would still be buses overland but less of them to allow for the streets, canals, buildings and pavements of Dublin to be less cluttered. Metro West could transform the Dublin public transport experience, our streetscapes and our quality of life.
