

Templeogue/Rathfarnham Core Bus Corridor

We live off Fortfield Road and attended 2 community meetings in relation to the Templeogue/Rathfarnham bus corridor and the Kimmage/Harolds Cross bus corridor proposed changes.

The immediate implications of these Badly Planned and not well thought out proposals to the area we live in and how we will navigate our way to the city centre or anywhere within our local environments or across city are as follows:

- (1) An unacceptable buildup of traffic all day long especially during the morning rush hour on Fortfield Road which will restrict access from our house, and cause considerable delays for us travelling on any of the local main roads. There will also be a knock on affect of the proposed Drimnagh Bus connects corridor on traffic using local roads in our area especially as we travel to the city or west from our home.
- (2) Fortfield Road will become a Permanent, though moving car park which will result in Noise and Air pollution.
- (3) Having looked extensively at the planning documents I have not been able to find the answer to a significant question: when the buses heading into the city centre arrive at the bottom of George's Street, where will they go to then? The city council are closing off Dame Street to traffic, and pedestrianisation of Parliament Street is also being considered. So the only route available is left at the bottom of George's Street towards Christchurch. And from that, another question arises: how are the buses going to get back up George's Street?

If these issues have not been addresses in the planning application, how can the permission be granted?

Also at the meetings we attended we were advised that the likely reduction in car journeys as a result of Bus Connects is in the region of 5%. The time savings is measured in minutes, (not more than 5 mins max from my recollection) according to the information we received. There seems to be little benefit gained from all of the proposed Bus Connect changes and the costs and inconvenience planned. So why proceed??

The level of spend on infrastructure as well as the destruction of grass verges and several tree lined areas, on Templeogue Road/Rathdown and along Terenure Road East for example, does not justify the end result.

Those proposing Bus Connects need to think of alternatives that cost less, cause less environmental damage, and give a better outcome.

Both of the proposed Bus Connects mentioned will have a detrimental effect on our daily quality of life which can be avoided by revising these plans to avoid the accumulation of traffic being directed on to Fortfield Road.
