Re: Planning Application for Ref ABP-320354-24 EDF Renewables Ireland limited. Coolnakisha The Ridge, Agharue, Seskinrea Co Carlow.

I wish to object to the above planning application; here I will outline my reasons.

- 1. We have our own drilled well supplying us with fresh clean drinking water and we are extremely worried about the water level, and the risk to our health and the health of our family from the possibility of pollution to our water supply.
- 2. We feel it will destroy our enjoyment of the scenic views of the local rural countryside and of the scienic Ridge Drive, which is on this route. We also are very keen walkers, and we feel our enjoyment of the peace and tranquillity of the area would be destroyed by the noise pollution and visual pollution height and blade diameter of these turbines, we also love to hear the beloved cuckoo singing out as we walk through the countryside here in Coolnakisha, with these turbines we will not hear these birds again.
- 3. Coolnakisha, The ridge, agharue, seskinrea is a very rural countryside with plenty of forest, but with the proposed development to cut down hectares of forestry so therefore nesting lots of wildlife e.g. rabbits, hares, foxes, nesting birds and many more such as the hen harrier, but with the large amounts of disruption by the dig and the felling of the forestry and by the heavy vehicles our wildlife will disappear.
- 4. This purposed wind farm is also flight path which we often see planes and helicopter's fly low across the hill.
- 5. As our home we have worked hard for, and lived for many years is situated very close to this proposed site, we feel our home will be devalued and we feel our enjoyment of the peace and tranquillity of our area would be destroyed by the noise pollution and visual pollution height and blade diameter of these turbines

The details unconfirmed in this application are the turbine tip height, rotor diameter and hub height. The range of parameters under which the turbine dimensions will fall are specified on this notice and in the design flexibility opinion that accompanies this application. The proposed development includes bridge strengthening works within the curtilage of a Protected Structure (Black Bridge – Kilkenny RPS Ref. D84). An Environmental Impact Assessment Report (EIAR) and Natura Impact Statement (NIS) have been prepared in respect of the proposed development and will be submitted to the planning authority with this application.
