ATHFHÓGRA MAIDIR LEIS AN AIGHNEACHT A RINNE COMHAIRLE CHONTAE NA GAILLIMHE CHUIG AN BORD PLEANÁLA AR 30 LÚNASA 2019 AR SHONRAÍ BREISE SUNTASACHA MAIDIR LE CÁS UIMHIR THAGARTHA ABP-302848-18

De réir Alt 51 (2) d'Acht na mBóithre 1993, arna leasú, rinne Comhairle Chontae na Gaillimhe iarratas ar cheadú chuig An Bord Pleanála an 23 Deireadh Fómhair 2018 maidir le Cuarbhóthar N6 Chathair na Gaillimhe atá beartaithe.

Cúireadh Tuarascáil Measúnaithe Tionchair Timpeallachta (EIAR) agus Ráiteas Tionchair Natura (NIS) ar aghaidh mar chuid den iarratas seo.

Thaisc an t-iarratasóir freagairt ar fhaisnéis bhreise leis an mBord Pleanála an 30 Lúnasa, 2019. Measadh an Bord Pleanála go bhfuil faisnéis bhreise shuntasach sna faisnéis bhreise maidir leis an tionchar a d'fhéadfadh an bheith ag an bhforbairt bheartaithe bóthair ar an timpeallacht. Foilsíodh fógra maidir leis an bhfreagra ar fhaisnéis bhreise ar 20 Meán Fómhair 2019. RE-ADVERTISEMENT IN RELATION TO THE SUBMISSION BY GALWAY COUNTY COUNCIL TO AN BORD PLEANÁLA ON 30th AUGUST 2019 OF SIGNIFICANT ADDITIONAL DATA IN RELATION TO CASE REFERENCE NUMBER ABP-302848-18

In accordance with Section 51 (2) of the Roads Act 1993, as amended, Galway County Council made an application for approval to An Bord Pleanála on the 23rd October 2018 in relation to the proposed N6 Galway City Ring Road. An Environmental Impact Assessment Report (EIAR) and a Natura Impact Statement (NIS) were submitted as part of this application.

A further information response was lodged by the applicant with An Bord Pleanála on the 30th August 2019. The further information was deemed by An Bord Pleanála to contain significant additional data in relation to the likely effects on the environment of the proposed road development. A notice in relation to the further information response was published on 20th September 2019. This is a re-advertisement of the 20th September 2019 notice and relates to the exact same further information response that was referred to in the 20 September 2019 notice. The further information response, together with the original application documentation, EIAR and NIS, may be inspected free of charge or purchased on payment of a specified fee (which fee shall not exceed the reasonable cost of making a copy) during public opening hours for a further period commencing on 6 December 2019 up to 24 January 2020 at the following locations:

Submissions or observations must be received by the Board no later than 5.30 p.m. on the 24 January 2020. Such submissions/observations must also include the following information:

- The name of the person making the submission or observation, the name of the person acting on his or her behalf, if any, and the address to which any correspondence relating to the application should be sent.
  - The subject matter of the submission or observation and
  - The reasons, considerations and arguments on which the submission or observation is based in full.
- Any submissions or observations which do not comply with the above requirements cannot be considered by the Board.

A person may question the validity of a decision by the Board by way of an application for judicial review under the rules of the Superior Courts (and in particular Order 84 of the Rules of the Superior Courts contained in S.I. **ROAD WORKS SPEED LIMIT ORDER**  
**SECTION 10 OF THE ROAD TRAFFIC ACT, 2004**

NOTICE IS HEREBY GIVEN that Galway County Council in exercise of the powers under Section 10 of the Road Traffic Act, 2004 and in the interests of road safety, has made an order to apply a Road Works Speed Limit of 50km/hr. to sections of road within the administrative area of Galway County Council as set out hereunder:
