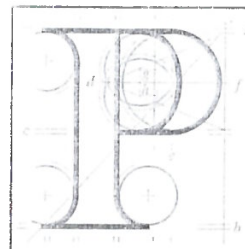

The delay involved is regretted.

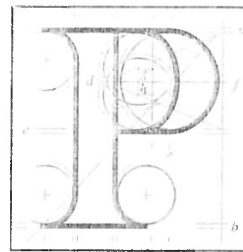

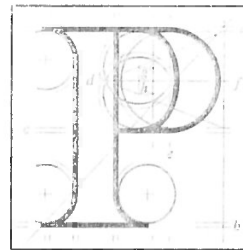
