Further to your correspondence on the above referenced appeals.

We have noted some incorrect information on the notices for both appeals. The issues are;

- 1. Statement on the substation application (ABP 308208-20) that a revised EIAR is submitted, where in fact this is the first EIAR for the project, originally it was an EIA Screening submitted.
- 2. Use of the word "revised" in the context of the wind farm application (ABP 208210-20) when in fact original document was an EIS.
- 3. Having documents available in West Cork for the Wind Farm application and Co. Hall for the Substation application. We believe for purpose of community participation it would be beneficial having both appeals available to the public at both locations.
- 4. Spelling of the townlands correct spelling is Barnadivane (Kneeves), Teerelton.
- 5. The Wind Farm notice refers to there been an AA Screening being prepared as part of the original application whilst the Substation does not.
