

Subject: Coole Wind Farm, Co. Westmeath in particular the proposed entrance to Peter Nixon's Land

George O' Conner, Community Liaison Officer from StatKraft informed us that the proposed entrance to Peter Nixon's land is on the Castlepollard side of the turn opposite to Margaret Mulligan's field and involves removing a substantial proportion of the mature hedge leading up to three residential properties that are occupied all of the time.

The exit from James Reynold's field where burrow pit is to be located is on the other side opposite Peter Nixon's field on the Granard side. We fail to see any logical reason for travelling up the road and around the turn when material will be coming from James Reynold's field.

The proposal to locate entrance on Castlepollard side of Peter Nixon's dividing ditch will inevitably leave the gate entrance to Margaret Mulligan's field of no value for moving livestock in and out.

The planning notice has been on the Granard side of the turn and suggested that the entrance would be on that side and appeared to us to be misleading.

The proposed entrance to Peter Nixon's land would cause great disturbance to the occupants of the three residences. We believe that the proposal is illogical and would cause unnecessary disturbance to residents.

We also note that the proposed hedge to be removed is of better quality than the section on the other side and would suggest that it is not an environmentally friendly action.

We appeal to you to make this relatively minor alteration that would make such a huge difference to our neighbourhood and maintain a small amount of the tranquillity to which we are accustomed.
