**REQUEST FOR TECHNICAL ADVICE IN RESPECT OF A PROPOSED STRATEGIC INFRASTRUCTURE DEVELOPMENT**

Dear Sir / Madam,

I refer to the above-mentioned proposed development which is the subject of a current application for planning permission. This application has been made directly to An Bord Pleanála under the provisions of the Planning and Development Act, 2000, as amended, in respect of proposed developments classified as strategic infrastructure development.

Please accept notification that this application relates to the provision of and establishment under the Chemicals Act (Control Of Major Accident Hazards Involving Dangerous Substances) Regulations, 2015. Furthermore, in accordance with article 24(9) of the aforementioned Regulations and article 215 of the Planning and Development Regulations 2001 (as inserted by article 41 of the Planning and Development Regulations, 2006) An Bord Pleanála hereby requests you to give it technical advice on the effects of the proposed development on the risk or consequences of a major accident.

A copy of the application in memory stick format including the environmental impact statement relating to the proposed development is enclosed for your information.

In accordance with the provisions of the said article 24(9) your response to this request should be furnished to the Board within four weeks of receipt of the request (unless within two weeks of receipt of the request you seek further information in writing from the applicant for permission). Any response to this notice should be received by the Board before 5.30 p.m. on the **16<sup>th</sup> December, 2021**.


