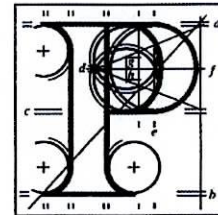

**Proposed Strategic Infrastructure Development (SID): Application for 10 year planning permission for an integrated wastewater treatment project referred to as the Greater Dublin Drainage Project. These works seek to construct a new regional WWTP at Clonsagh, a pumping station at Abbotstown and associated pipelines from Blanchardstown to a final termination point at seabed level approx. 1km north east of Ireland's Eye in the Irish Sea in Fingal, County Dublin.**
