Dear Ms.Reilly

Thank you for this opportunity to provide general observations on application by Irish Water ABP - 312131-21.

Our overall observation relates to the lack of FIELD experiments relating to Environmental Impact Surveys in all aspects of the entire proposed GDDS project. Such EIS surveys should by carried out by properly qualified Scientists employed by The Environmental Protection Agency (EPA)

The recently enacted legislation requiring County Councils to have legal responsibility relating to the Marine Coastline, now require a thoroughly new investigation into all Marine aspects of this project, as follows. :

*. The proposed strategy of DREDGE and FILL across Portmarnock Velvet Strand is totally inappropriate for a Blue Flag Beach. Changes to sand deposition patterns and to tidal channels on the sand spit will likely result in the

destruction of the beach, as happened when RPS carried our dredge& fill in the Blue Lagoon in nearby Sutton Strand in 2008. Desk Top submissions are entirely inadequate relating to such a vital matter of public recreation as Portmarnock Beach.

*. The entire Irish Water Submission for the Oral Hearing in March 2019 was based on plans for the treatment plant in Clonshaugh to contain Primary and Secondary Treatment only. There were no plans submitted for Tretiary Treatment until the Thursday prior to the commencement of the Oral Hearing. Thus, members of the public and interested bodies had no opportunity to assess the effectiveness of tertiary treatment, due to lack of such plans.

It should be noted that recent studies by the EPA in 2022 found that Covid virus has been detected in the receiving water of 48 Irish WWT Plants.

Obviously, detailed proposals ,overseen by Scientists from the EPA, for up to date methodologies on how to deal with viruses such as Covid, CPE, polio, prions , plasmids, phages, must be published ,relating to how these organisms will be dealt with, especially how these organisms respond to saline receiving waters. Experts in the public domain should then be provided an opportunity to respond to these proposals.

*. Recent Bathymetric Studies of the Sand Banks of Kish , Shelley Banks and Coastline of Fingal County Council , have shown the dynamic and moving sand bank off Ireland s Eye , the proposed location of the outfall pipeline.

The Bathymetric Desk Top Model of the proposed outfall pipe is no longer valid, since the deep dip in sand at that location has shifted, and has moved northward in 2022. Luckily, that location was not enforced,

since the dynamic shifts in sand depth along this entire sand bank require any proposed outfall pipe to be located many kilometres further out to sea.

*. Howth Fishermen are extremely worried about a pipeline off Ireland's Eye. The EPA should work hand in hand with the fishermen relating to any consequences from the proposed outfall pipeline, regarding catch size, fish & shellfish eggs, nets etc.
