The proposed sewage plant mentioned above is now in the final phase of planning. I confirm that I object to the above proposed project and location. I enclose a fee of 50.00euro with this letter. The objections are listed below:

Health and Safety:

As a resident and a parent living in the area for over 20 years I have great concern for my two children who have suffered from asthma their whole lives, that their health could be effected by air pollution caused by day to day works at the plant and/or a major incident. There is no guarantee that an accident will not happen in the proposed plant as it did in the Ringsend plant shortly after becoming operational; which resulted in employees admitted to hospital

Noise Pollution:

Due to operation of the plant local residents such as myself will suffer constant and ongoing noise pollution.

Odour:

No guarantee can be given to local residents that there will be no odour from the plant. Assurances were given to those that lived surrounding the Ringsend plant, yet they had to endure odours. The size of this particular plant is a major worry in regard to odour as no measures put in place could supress this.

Traffic:

Currently the backlog of traffic from major roads such as the N32 and M1 create congestion around the residential area of Clonshaugh/Priorswood and this will only increase with the volume of traffic if this plant goes ahead. This will also increase the dangers endured by traffic congestions on roads that house young children and families.

As a concerned parent and resident of Clonshaugh I am outraged at the proposal to build such a large sewage plant that is surrounded by a largely populated residential area of young families and children. This will not only affect the livelihood of those in Clonshaugh but also areas stretching out as far as Darndale, Belmayne, Kinsealy, Clarehali, Portmarnock and Blog PD P I would ask that An Bord Pleanala to review this proposal again in lightrof the issues and concerned highlighted. 1 6 AUG 2018
