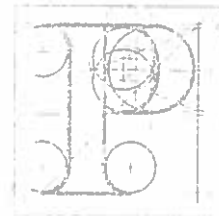

To Whom It May Concern,

The proposed sewage plant mentioned above is now in the final phase of planning. I confirm that I object to the above proposed project and location. I enclose the fee of €50.00 with this letter. The objections are listed below.

- The plant will have a huge environmental impact on my local area.
- There will be a foul smell in our area and this will reduce the amount of time my family and I spend outside, thus reducing the quality of our life and physical health.
- The house prices will be greatly impacted in the area.
- Local businesses will suffer as nobody wants to visit a place that smells of excrement.
- All of our children will be still expected to play outside during government decided breaks in schoolyards that stink and air that is unhealthy ie. similar to the situation in Ringsend.
- We will be unable to open our windows because of flies and bluebottles that will inevitably infect us with germs, thus the quality of air inside our homes will be impacted.
- Transport links which are already under immense pressure in the area will be worsened.
- All of our local schools including some of the most vulnerable people in our community in St Michaels house will be affected as they are located on the N32.
- The local community has been kept in the dark about all of this.
- Our beaches will be contaminated and no longer have blue flags.
- Were there to be an accident at the plant my family would be in danger.
- Irish Water have already paid out substantial fines recently due to their inadequate performance dealing with similar issues.

I would ask that An Bord Pleanála review this proposal and location in light of the issues and concerns highlighted above.
