To whom it may concern

The proposed sewage plant mentioned above is now in the final phase of planning. I confirm that I object to the above proposed project and location. I enclose the fee of €50.00 with this letter. The objections are listed below:

- Extremely poor public consultation and information sharing with the communities in the immediate vicinity of the proposed location. The scale and potential impact of the proposed facility should have had much broader public awareness events.
- Odour The location of the proposed plant will be next to some heavily populated communities to the South and East. These communities that boarder the proposed plant include Clonshaugh, Priorswood, Cara Park, Northern Cross, Balgriffin, Clarehall and Ayrfield. Any odour from the proposed plant will have a detrimental effect on these communities. There has been multiple documented odour issues with the Ringsend water treatment plant since its inception, there is nothing to suggest that this plant will not have the same issues.
- Area has historical significance In 17th Century the Lord Mayor of Dublin, Sir Humphrey Jervis built a house on the property, Belcamp House, where Henry Grattan lived and Dean Swift often visited. Countess Markievicz rented the property in 1909, and it was also used as a centre for the Fianna Eireann. The building of the proposed plant with completely remove all reference to this historical location.

I would ask that An Bord Pleanala to review this proposal again in light of the issues and concerns highlighted.
