The proposed sewage plant mentioned above is now in the final phase of planning. I confirm that I object to the above mentioned proposed project and location. I enclose the fee of €50.00 with this letter. The objections are listed below:

- I feel this facility is too large and too close to a residential area where I live and where Schools and Youth services are located and where I enjoy walking in my local park beside the proposed facility. There is the possibility of bad smells coming from this facility and a safety concern.
- Also, I am a keen water sport enthusiast and regularly enjoy swimming at Portmarnock beach and I feel the outflow will negatively affect sea water quality.
- I am a Scuba diving Instructor and regularly Scuba dive in the waters offshore at Howth, Lambay and Portmarnock and I feel the outflow will negatively affect sea water quality.
- On traffic on the N32/ R139 I feel it is already a congested road and the added amount of trucks entering the facility will have negative consequences for road traffic congestion in the area.

I am asking that An Bord Pleanála review this proposal again and in light of the issues and concern highlighted.
