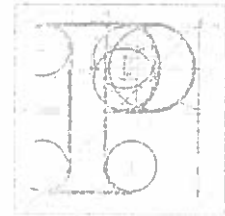

The proposed sewage plant mentioned above is now in the final phase of planning. We confirm that we object to the above proposed project and location. We enclose the fee of €50.00 with this letter. The objections are listed below;

- Disruption during the construction of the plant to the local residents.
- The height and large build of the plant is going to take away a large green belt left in the area.
- The threat of pollution in the area due to the malfunction after construction
- The lack of consultation with residents in the Clonshaugh area. (1 Consultation Meeting in 6 Years).
- The size of the plant.
- The closeness of the plant to such a densely populated area.
- The threat of economic development in the area.
- The effect this will have on residents in the area that are already crippled with negative equity for the homes they own with the resell value to decrease even further.
- A local G.A.A. club have playing fields in close proximity to the proposed location which will have a major impact on the physical and mental wellbeing of young people of the area.
- The Odour- given the size of the plant when constructed if something goes wrong with the equipment after the building is completed.
 - The odour when tourists disembark a plane at Dublin Airport to visit the Emerald Isle will change people's views of our beautiful country.
 - To have a simple pleasure of a Barbeque in our gardens will be a thing of the past
 - Children will no longer be able to enjoy the green fields and fresh air in the area.
- The effect the disposal of waste will have on Blue Flag beaches in the area (Malahide, Donabate, Dollymount
- We would like the An Bord Pleanála to consider the 2 other locations proposed for the plant.

We would ask that An Bord Pleanála to review this proposal again in light of the issues and concerns highlighted.
