Dear Sirs,

I wish to the object to the above pipeline scheme and sewage treatment plant Compulsory Purchase Order Application to An Bord Pleanála by Irish Water.

The following is not an exhaustive list of all of the points that I wish to raise and as additional information becomes available, I will intend to raise further matters at the Oral Hearing which I expect will be held by An Bord Pleanála in relation to the above project:

Route Selection

I believe the route selection process has been flawed on this scheme and a better route could have been found for the pipeline and a better location could have been found for the sewage treatment plant. The plant could have been located on IDA's zoned lands or alternatively in a location well away from any dwelling houses. I feel this will cause havoc to our daily routine with school going children and work ourselves.

Environment

I believe this project has the potential to cause significant negative impact on the environment both on the on land route and in relation to the outfall location at the sea. This is of concern to me and my interest in environmental issues

Planning

I believe that this project has not been properly planned and developed to the point that it currently is at.

Time Lines

I believe it is a complete abuse of process that this project has been now planned for a long number of years with no clarity to the local people including ourselves as to when the project would be progressed or constructed. There still is no clarity with regard to the start date or the completion date. This is completely unacceptable that the State should


organise a project in this manner. It is a disproportionate use of compulsory purchase powers. A scheme such as this should not be commenced until there has been funds ring fenced and put to the one side and specific deadlines for all stages of the project are put in place. Effectively this area of the countryside has been plighted now for many years and will continue to be so by this huge infrastructure project hanging over it. This is unnecessary and unacceptable and An Bord Pleanála should take this into account in its adjudication on the project. This is totally unacceptable and unfair to the local people and communities surrounding.

Further Concerns

I have numerous further concerns in relation to this project particularly in relation to the treatment plant and how it will be operated and its impact on the environment including odours, attraction of flies, vermin and so on.

I request that An Bord Pleanála hold an Oral Hearing and I request that I be given an opportunity to put some of my concerns to the Irish Water personnel who will be present at the Hearing.
