Re: Irish Water planning application for Wastewater Treatment Plant at Clonshaugh D17
Reference number 06F.PC0152. We are strongly opposed to this proposal.

With the location being close to the populated areas of Clonshaugh, Priorswood, Damdale, Clarehall, Belmayne and further, a waste treatment plant will impact greatly on the amenities of these areas, Parklands, AUL Sports complex and Hotels within this catchment.

There is a major worry regarding odour from such a massive plant and this is inevitable as is the case with other facilities of similar type, there is also a worry over increased noise from heavy traffic trucks etc. on a 24 hour bases to service this plant.

As this plant will only be of secondary treatment the danger of pollution from any system failure will have devastating effect on many surrounding areas including beaches along the pipeline where it is proposed to exit the waste into the sea.

We feel smaller more localised plants should be used for the treatment of sewage where there is less risk of a major environmental issue.

Further we feel that the proposed treatment plant will have a lasting detrimental effect on this area.
