Section 37E(4) of the Planning and Development Act, 2000, as amended requires you to submit to the Board a report setting out the views of the authority on the effects of the proposed development on the environment and the proper planning and sustainable development of the area of the authority within a period of 10 weeks from the making of the application to the Board. The application was made to the Board on the 28th January, 2022, and I can confirm that the deadline for the submission of the planning authority report is therefore 5.30p.m. on 8th April, 2022.
