

A Chara,

We are a group of active and concerned local citizens who are vehemently opposed to this development due to the adverse effect it will have on our quality of life, on our community and on our living environment.

Our objections are as follows:

Lack of meaningful consultation and transparency.

The developers [according to their application] pride themselves on community consultation but the reality is that by the time the community was invited for consultation, the local landowners had already been approached and tied into contracts. This is dishonest and shows a willingness to be underhanded with the local community. This attitude has been echoed several times with surveyors being caught trespassing, being openly dishonest about their intentions and lying about their employer and blatantly trying to shut down community led meetings [pre-covid] about the proposals. We can attest to all of this.

In one instance a local farmer contacted the developers to object to the fact that both his [P51 E434] and his parent's house, their farmyard and lands had been included in a photograph which had been published in their brochure - giving the mistaken impression that they are in favor of the development. He was met with a totally dismissive attitude and informed that as the photograph had been taken from the public road, he had no rights.

As a final point it has been impossible in the present climate to hold public meetings to provide an effective opposition to this development. For this reason alone this development should not be approved.

Harm to Quality of Human Life.

We have many concerns as to how the introduction of 20 wind turbines into the local vicinity will affect our daily lives. First and foremost, we are extremely worried about losing the beautiful scenic landscape we call home. On top of that, the negative effects of living in proximity to windfarms has been well documented, and this information is readily available – we don't need to include all of the science here. However our concerns include – but are not limited to:

Noise: Wind turbines are noisy and they run day and night. Studies have proved that they affect people's sleep, and create a continuous, low frequency noise that can have a hugely stressful effect on people, especially those sensitive to sound.

Shadow Flicker: Wind turbines, like all other tall structures, can cast long shadows when the sun is low in the sky. The effect known as shadow flicker occurs when the rotating blade blocks the sun and causes the shadow to flick on and off. These shadows can stretch for long distances depending on the turbine height and orientation of the sun. When this is part of your daily experience it is hugely stressful and can be a trigger for those suffering with epilepsy.

Autism: It has been well documented that individuals on the Autism Spectrum experience a degree of sensory impairment which renders them extremely sensitive to specific sounds, light and reflection and in many cases touch. To this end, it is reasonable to assume that individuals on the Autism Spectrum will be even more susceptible to infrasound, mechanical noise and shadow flicker from the wind turbines than the general population. In our area there are quite a number of people in the immediate vicinity who would be directly affected because of health issues.

Tourism: On any given weekend, and often during the week, hikers can be seen climbing up and down Musheru. The mountain and the Duhallow Way are popular with visitors, and walkers support many business in the area, from B&B's and accommodation to cafes and shops. Putting a wind farm in the

middle of this will undoubtedly send visitor numbers plummeting – and with it, the income they bring in to the area.

Biodiversity Loss and Harm to our Living Environment.

According to Cork County Council's own planning guidance "Planning Authorities have a responsibility to safeguard biodiversity, and are legally obliged to assess the potential of all planning applications that come before them, to determine whether the proposals contained therein could have impacts on our environment". We would argue that the proposal will have significant impact on the local environment, and that in their responsibility to safeguard biodiversity, the proposal should be denied.

The upland habitat of Musherah and its surrounds is home to many species of plants and animals/birds listed on the red or amber endangered species list. Preserving this declining habitat is fundamental to ensuring that these species have a chance of survival. The following is a list of birds on Birdwatch Ireland's red and amber lists which either make Musherah their home or regularly visit it for the purpose of feeding or breeding.

Red List: Red grouse, woodcock, barn owl, meadow pipit, grey wagtail, redwing, golden plover, snipe & kestrel. Both the white tailed eagle and red kite have also been observed in the proposed site.

Amber list: Marsh harrier, hen harrier, merlin, chough, skylark, swallow, starling, northern wheatear, goldcrest, house sparrow, tree sparrow, greenfinch & willow warbler.

We can attest to all of these sightings.

Of particular concern is the hen harrier, a beautiful bird of prey that is under severe threat in Ireland, largely due to declining habitats. We know of six nesting sites within 5 kms. of the proposed development site and there are many more potential sites. We are extremely concerned that the proposed development, by removing yet more of their habitat, would prevent the birds from both nesting and feeding in the area.

Significantly, the area is also a favored spot of the **Devil's Bit Scabious**, a small plant that is the only food of the caterpillars of the endangered **Marsh Frattillery butterfly**. The endangered Kerry Slug is also to be found on the site.

As well as these endangered species, Musherah and its surrounds provides homes for red squirrel, badger, stoat, mountain hare, foxes, hedgehogs, voles, frogs and countless other wildlife, whose homes and habitat will be directly threatened by the proposal.

Any sediment run-off to the Blackwater will affect the habitat of the Freshwater Mussel.

This sensitive up-land habitat which is dear to us all, will be destroyed forever if this windfarm is allowed to go ahead.

Archology: The Musherah area is home to the richest concentration of prehistoric archology in Northern Europe. A plethora of standing stones, wedge tombs, and holy wells can be found all across the area.

The developers propose to put a marked trail highlighting these sacred spaces. In our opinion, this adds insult to injury.

Only a small number of people stand to benefit from this development – the rest of us are expected to suffer the consequences of it.

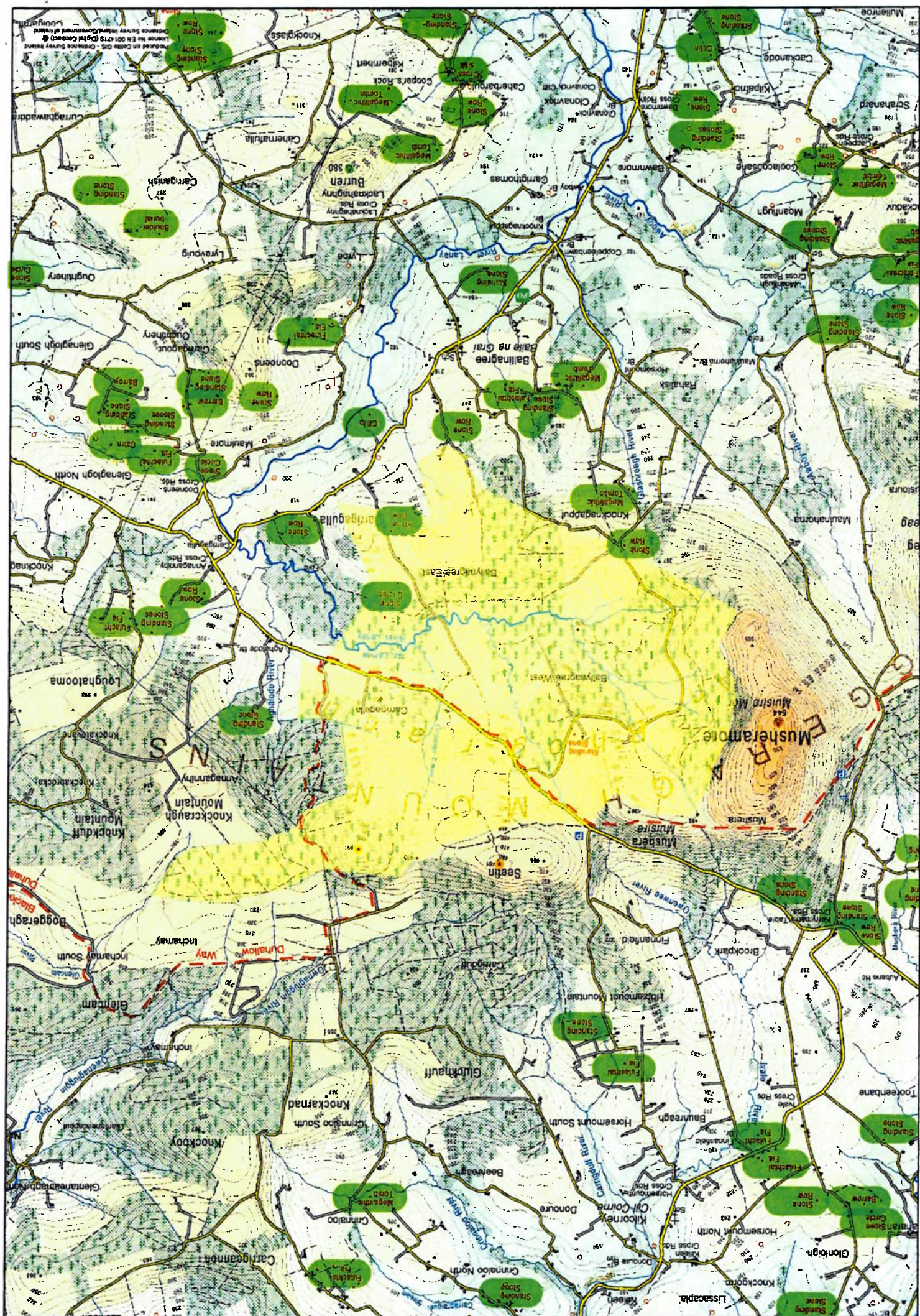
