

My observation concerns the silence in the planning permission on the expansion of the use of the jetty in Marino Point. I was under the impression that intensification of use of the jetty would be subject to a separate planning permission which doesn't seem to be the case.

The original planning offered protections in terms of noise pollution concerning "tonal and impulsive" noise. This seems to have been a concern in terms of granting the original permission however it has not been considered in terms of the use of the jetty.

My experience of the limited boat traffic at the jetty while a resident of Passage West has been that diesel generator's are left running overnight either on the quayside or on the ships. This is noise is by its nature tonal and impulsive. It seems to be that giving regard to this form of noise pollution in prohibiting it should be consistently applied whether it be in the Gouldings development or at the jetty, particularly given the population density some 400-500 metres across the water in Passage West.
