The grounds of my observation relate to the amenity impact upon the preexisting residents around the SHD. Attached are photographs demonstrating current views of the village from Sweetmount and from Finsbury Park. Sweetmount will effectively be walled off from its current panorama- here the exemplar is the Taney Church. The ACA only applies to the main street and direct environs and the development even at 5 storeys will divide Dundrum Heights (not just Sweetmount) from the village proper. No development prior to that (the bypass, the aqueduct redirect etc.) has had that effect. The 'reinstitution' of a pedestrian bridge is not to facilitate access but force footfall through Sweetmount. The previous bridge was as a stop gap measure with respect to the redevelopment of the Dom Marmion bridge after which it was removed. Finsbury will suffer similarly, rendering pointless much of its recent redevelopment (open view fencing replacement of obscuring walls, making for a more secure space and amenity), as the new shadow fall will serve to (albeit seasonally) obscure the St. Nathi Church end.
