In respect of the above-mentioned proposed development, I would like to note the following observations:

- The height and design of the proposed development is of significant concern. It conflicts with the scale and character of the current Dundrum village streetscape and will likely contribute to a significant loss of daylight in the surrounding streets.
- 2) The proposed development will lead to a reduction in retail provision on the main street of Dundrum and will undermine the significant efforts made by many during the COVID-19 pandemic to revitalise the street as a space conducive to sociability and connection.
- 3) The proposed development will result in a significant increase in traffic levels in the area. Again, this will undermine the various attempts that were made during the pandemic to make Dundrum village and surrounding areas more conducive to walking and cycling, in particular for younger members of the community.
