Observations on The Hammerson Allianz SHD Plans for Dundrum Village

- The height of the buildings are totally of scale with the buildings in the surrounding area.
- 2. They are out of character with the nature of the old Village.
- 3. These buildings would block light from the houses in the sweetmmount residential area.
- 4. This development would involve the demolition of historic buildings on Main Street which are designated as an Architectural Conservation Area in the new County development Plan 2022- 2028
- 5. There is limited provision of retail entertainment and services as required by Town Centre Zoning. As a local resident there would be no Village to visit as there once was when I was a child
- 6. There is no employment on sight for residents. They will need to travel to work increasing the load on an already over crowded Luas.
- 7. Traffic around Dundrum is already heavy an increase in population of this size will put further pressure on bottle necks.
- 8. The Development should be built to house a community and be the centre of that community where people can work, live and meet.
