The current Hammerson Allianz proposed development will be 95% residential, and as such is a material contravention of the zoning of this site under the Major Town Centre status of Dundrum Village. This is exactly the same opinion ABP expressed in your opinion of 14/01/22.

The proposed open space at the back of the church is too small, allows for no passive surveillance from surrounding buildings, is potentially inaccessible or at best, accessible with difficulty by people with a disability, which hard coded discrimination should ensure the rejection of this plan.

5. Grounds

The overall scale of the development, the lazy lack of differentiation in the architect and design of the buildings, and the almost inescapable conclusion, judging from the make up of the apartments, is that this is designed as a vehicle for Hammerson and their backers Allianz to monetise the building and either shift them to a SPV for indefinite rental at exorbitant rates or flip them to a pension fund. Either outcome negates them even pretending to provide sustainable or long term stable housing in this sensitive geographical location.

I wholly expect you to reject this ill conceived proposal on the material contravention and your own observations of its shortcomings.
