I live close to Dundrum Village, and I believe the proposal to construct 881 Apartments on the old shopping centre site is an excessive amount of residential accommodation on this site. This site should be a neighbour centre where there are shops, offices, an hotel, civic facilities and residential accommodation but not, almost, all residential accommodation. I accept that the old shopping centre needs to be developed and I agree that there should be residential accommodation in it, which is suitable for a village like Dundrum

Also, some of the residential accommodation should be available to purchase so that residents in 3 and 4 bedroom houses in the area can downsize to Dundrum Village and free up these houses for families.

In summary I am totally opposed to the current application, and it should be rejected.
