

1: The layout and design of Hazelbrook Estate cannot facilitate a through road from Kinsealy Lane through to the new development.

- Kinsealy Lane infrastructure is not suited for increased volume and is unsafe to walk/cycle currently. Inadequate foot and cycle paths along the full length.
- Far proximity to public transport and lack for cycle/foot paths will force vehicle use.
- The Southern Quarter will triple the number of dwelling in the existing Hazelbrook Estate. Hazelbrook will become unsafe on all roads for children and will lose any sustainable/green building and design.

2: Increased housing numbers in the Southern Quarter will add to the already stretched schooling system in the area. We are currently outside many schools zones and to add Portmarnock schools into this assessment is a gross manipulation of a feasibility report.
