Our grounds for concern with this development and the basis for our observation is specifically the impact of linking the roads from the new development through Hazelbrook and onto Kinsealy Lane. We are residents in No. 25 Hazelbrook and are located immediately at the entrance road leading onto Kinsealy Lane.

The linking of roads between Hazelbrook and the new development would have a significant negative impact from the perspective of increased traffic volumes and increased risk to the health and safety of our children from vehicles. Hazelbrook is a small development, and we selected this development as it provides a safe environment for our children. The infrastructure, in particular the entrance onto Kinsealy lane is not suitable for increased traffic volumes. It is a challenging junction to navigate and increased traffic (est. 4 x 5 times based on the number of units in the new development) would further increase the risk of an accident via an entrance that at peak times is already at capacity. The linking of the new development, would in-turn, create an alternative route to travel from the back road to Kinsealy lane. This would result in non-residents using the route which would compound the risk borne to children and residents from road traffic, noise and road pollution.

The impact is both to our house which is directly on the proposed throughroad and also to the recreational greens where our children play with the

friends of our neighbours. Undoubtedly there will be a serious impact for a number of years during construction with contractors using the throughway and this will be increased with the public using the throughway when construction phases are complete. Construction has only recently completed in Hazelbrook and there was considerable levels of dirt, dust, debris and danger to our children during the construction of this small development. The disruption will be magnified by a development that is approximately 10x the scale of Hazelbrook. It appears that the risk to the health and safety of our children has not been considered and an unnecessary throughway is being added which was not originally part of the new development plans.
