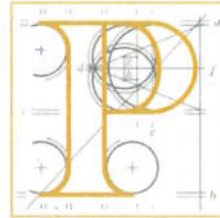

Dear Sir / Madam,

I refer to your email dated 23rd October, 2025 and note your instruction regarding the National Transport Authority's change of address. Please be advised that the content below is from a previous letter issued to the National Transport Authority on the 28th August, 2025 as follows:

I have been asked by An Coimisiún Pleanála to refer to the above-mentioned application and to the Commission Order dated the 19th December, 2023.

Please note that a clerical error occurred in Condition 16 of the Order which stated that a 'A suitably qualified archaeologist shall be appointed by the local authority to oversee the site set-up and construction of the proposed development and the archaeologist shall be present on site during construction works.'

Condition 16 should read as follows:

The developer and/or any agent acting on its behalf shall facilitate the preservation, recording, protection or removal of archaeological materials or features that may exist within the site as set out in the Environmental Impact Assessment Report. A suitably qualified archaeologist shall be appointed by the developer to oversee the site set-up and construction of the proposed development and the archaeologist shall be present on site during relevant construction works. Should archaeological material be found, the archaeologist may have work stopped and the developer shall carry out the necessary mitigation/recording. The planning authorities shall be furnished with a report describing results of monitoring.

Reason: In order to conserve the archaeological heritage of the site and to secure the preservation and protection of any remains that may exist within the site.

Henceforth, the Commission's Order should be read in conjunction with this letter.
