Dear Ms Reilly,

We refer to your letter dated 1 July 2024 to Transport Infrastructure Ireland (TII), directing that all materials submitted to the Oral Hearing together with the revised Book of Reference (collectively the Oral Hearing Documents) are to be put out for public consultation. The Board has requested that TII:

- (i) make the Oral Hearing Documents available on the dedicated MetroLink website;
- (ii) notify the public by newspaper that the Oral Hearing Documents will be available for review (and specify the locations and time-periods for inspection); and

2 PUBLICATION OF NOTICE AND MAKING SUBMISSIONS

UPDATE

Public consultation on information submitted during the MetroLink Oral Hearing

An oral hearing was held before An Bord Pleanála (the **Board**) from 19 February 2024 – 28 March 2024 into the application of National Roads Authority (operating as TII) for a Railway Order (**RO**) for the MetroLink project (the **Oral Hearing**).

Since over 17 months had passed since the submission of the RO application in September 2022, the Board requested a number of updates and further information to be submitted on Day 1 of the Oral Hearing on 19 February 2024. Over the course of the six-week Oral Hearing, further additional information was presented to the Board in response to queries from both the public and the Inspectors. Furthermore, pursuant to a Request for Further Information issued by the Board, TII submitted on 12 June 2024 an updated Book of Reference to the plan indicating the identity of the owners and occupiers of the lands described in the plan. All of the above additional documentation is collectively called the **Further Information**.

In order to ensure that the public has a sufficient opportunity to review, consider and comment on the Further Information, the Board has directed that TII provide for a secondary public consultation period.
