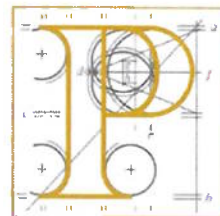

Dear Sir / Madam,

I have been asked by An Bord Pleanála to refer further to the above mentioned proposed development which is before the Board for consideration.

Please be advised that the Board, in accordance with section 37 of the Transport (Railway Infrastructure) Act, 2001, as amended by section 41 of the Planning and Development (Strategic Infrastructure) Act, 2006, hereby requires you to furnish the following further information:

1. It is noted from TII's written responses to the written submissions and subsequent submissions at the oral hearing that a number of modifications are proposed to the Draft Railway Order Book of Reference to address errors, to clarify extent or nature of proposed acquisition and to reflect proposed modifications arising from the oral hearing.

You are requested to submit an updated Book of Reference and associated property drawings, as appropriate, to clarify this matter. In the interests of clarity this updated Book of Reference should also incorporate the proposed updates presented at the oral hearing (for example in the witness statement of Michael Horan and the R132 landscape amendments, both presented on 19th February 2024).

Any proposed changes to the Book of Reference should be clearly indicated through the use of colour or with a table in a separate cover letter.

The further information referred to above should be received by the Board within 3 weeks from the date of this notice (i.e. no later than 5.30 p.m. on the 16th May 2024).

In this regard, please submit 3 hard copies and one electronic copy of the above information. The electronic copy should include a word document copy which can be edited.


