Introduction

The National Roads Authority (operating as Transport Infrastructure Ireland) has applied to the Board under section 37 of the Transport (Railway Infrastructure) Act 2001, as amended, for the Railway (Metrolink – Estuary to Charlemont via Dublin Airport) Order 2022.

The Railway Order, if approved, will authorise TII to carry out railway works and all works necessary to enable the construction, operation, maintenance and improvement of a railway designated as a metro including, inter alia, the construction of a fully segregated and automated railway and metro mostly underground c. 18.8 km in length with 16 stations running from north of Swords at Estuary through Swords, Dublin Airport, Ballymun, Glasnevin and the City Centre to Charlemont in the south of Dublin City Centre.

The Railway Order, if approved, will allow TII to acquire compulsorily land or rights in, under or over land or any substratum of land specified in the order; to temporarily acquire and occupy land specified in the order; to acquire easements and other rights over land specified in the order; to extinguish public and/or private rights including rights of way specified in the order; and provides for other rights over land.

- **Overview of Main Issues Arising:**

- Construction phase impacts: noise, vibration, settlement, property damage, dust, traffic, access, air quality, electromagnetic interference, vermin control, water quality impacts, impacts on businesses.
- Operational phase issues: air quality, noise, vibration, traffic, anti-social behaviour, impact on property values.
- Design of stations.
- Alternatives: Alternative to metro; alternative route alignments, alternative depot and station locations; alternative southern terminus; opposition to Charlemont Station.
- Failure to serve south west Dublin and failure to 'future-proof' for extension.
- Excessive land and property acquisition; excessive loss of housing; loss of leisure centre; impacts on residual lands and development potential.
- Impact on theatres, hotels, schools, churches, hospitals and laboratories.
- Landscape and visual impacts.
- Inadequate consultation and engagement.
- Built heritage impacts.
- Residential amenity issues (noise, dust, loss of privacy, overshadowing, exhaust fumes, traffic etc.).
- Access, parking and drainage issues.
- Biodiversity and Appropriate Assessment issues.
- Monitoring, communications, remediation measures.

Recommendation

Having regard to: the nature and extensive scale of the proposed development; the potential planning and environmental issues arising; the public interest in the case; and noting that a substantial amount of land, rights over land and properties are proposed to be acquired, I recommend that an oral hearing be held.

I further recommend that the applicant be invited to provide a written response to the submissions received in advance of the oral hearing, in the interests of facilitating a more expeditious and efficient hearing.
