## RE: SUBMISSION REGARDING THE METROLINK RAILWAY ORDER ABP ORAL HEARING WITH RESPECT TO LANDS AT EARLSFORT TERRACE, DUBLIN 2

## Introduction

## **Draft Guidance Note for Developers**

A Draft Guidance Note for Developers has been published by TII on the Metrolink Railway Order website. There has been limited time to review this document and its potential implications. The purpose of the document is to assist developers in understanding TII requirements for protection of MetroLink, and to provide guidance to developers on future development which may be undertaken.

We are advised by Punch Consulting Engineers, that the depth of the tunnel has a direct correlation with the potential loading above i.e. the deeper the tunnel, the greater the loading that may be placed above, which has direct implications for development potential.

Having regard to the request for the tunnel to be lowered at this location relative to potential building damage, it is respectfully submitted, that lowering of the tunnel alignment may assist in addressing our clients concerns relative to the potential impacts on development potential of the subject site, subject to further structural assessment.

The matter of impacts of the positioning of the tunnel on development potential for the subject site will be addressed in Module 2 on behalf of our client.

## **Concluding Comment**

We trust that An Bord Pleanála will take this submission into consideration in determining the Railway Order.
