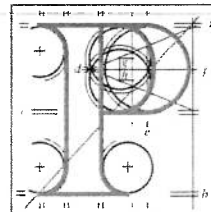




Along with many of our neighbours we ask that the Bord refuses permission for the section of Metrolink from St Stephen's Green to Charlemont.

However, should permission be granted, we ask that the Bord makes it condition of the Railway Order

- that the Diaphragm Method of construction be used in the creation of the station box.
- that TII indemnify the residents of Dartmouth Square West against all loss and damage and restore our homes to their original condition
- that TII provide a triple glazed solution for the windows of our homes
