



## Observations of CLG Na Fianna

Is club Chumann Lúthchleas Gael é CLG Na Fianna. Tá an club suite ar Bhóthar Mobhí, Glasnaíon. Tá timpeall 3000 ball páirteach sa Chlub. Tá timpeall 200 foireann againn - fóirne do bhuachaillí agus cailíní agus iad ag imirt peile agus iománaíochta agus camógaíochta, agus fóirne d'fhir agus do mhná fásta ag imirt cluichí go léir an CLG. Imrítear liathréid láimhe agus an cluiche corr sa Chlub chomh maith. An club spóirt is mó i dTraisceart Bhaile Átha Cliath is ea an club seo. Ach tá tuilleadh - is áis iontach cultúrtha don phobal é an club chomh maith. Is croí an phobail é. Cothaíonn an club deasláinte - sláinte intinne agus sláinte corp - i measc an phobail uile i nGlasnaíon, i nDroimConrach agus i mBaile Phib agus in áiteanna eile máguaird. Is eard atá san aigneacht seo ná tuairim an Chlub mar gheall ar thogra an TII don Metrolink.

This Submission is made on behalf of CLG Na Fianna and its members (Na Fianna). Na Fianna is a unique sporting, cultural and community based volunteer Gaelic Community whose scale and influence in local community life (be it sporting, social or cultural) in a city environment is without parallel. Membership numbers define us as the largest participatory sports and cultural community in North Dublin.

The activities of Na Fianna are conducted upon a number of sites which are directly and indirectly affected by the proposed construction of the MetroLink. The sites directly impacted include St Mobhí Road and Collinstown Lane and the sites indirectly affected included Albert College Park and St Vincents CBS.

Na Fianna is supportive of a Metro rail service for North Dublin and acknowledges the benefits it may bring to our Community. Na Fianna acknowledges the positive engagement of TII/NTA with the very serious concerns raised by our community to the emerging preferred route initially published in 2018.

Whilst many of the strategic concerns raised by our initial submission have been addressed through direct dialogue, operational concerns remain in relation to the construction process. The construction phase should endeavour to minimise the disruption it brings to our members day-to-day activities and our wider community.

The following are the issues upon which we seek further clarification:

- The works on the St Mobhí Road site will severely impact on local residents and a number of active sporting and educational institutions including Na Fianna, Scoil Mobhí, Scoil Chaitríona and Whitehall College. Recognising the intensity of use of the site and its impact on such large numbers of users we suggest that a condition of the granting of the RPO should stipulate that the full traffic and health and safety plans for this site are prepared in conjunction with the stakeholders in the direct vicinity. The stakeholder group should include a representative of each educational institution, each sporting group and a residents representative.
- Prior to construction a process of monitoring and dealing with issues arising should be agreed. In the event of recurring breaches of safety/ traffic plans a process should be agreed for an independent form of adjudication to deal with any substantive unresolved issues encountered during construction.
- In addition to the site works on St Mobhí Road we wish to clarify that the
  construction works as outlined in the RPO will not disrupt the use of public
  facilities enjoyed by Na Fianna in the public park of Albert College.
- In relation to the site of Collinstown Lane we wish to ensure that all enabling works are conducted in such a manner as to minimise impact on the community based activities on this site.

Na Fianna welcomes further detailed engagement with TII to ensure the project is delivered with maximum community support to ensure a minimum of disruption and the legacy of long term community gain for all.
