

Observation on Case reference: NA29N.314724 Estuary through Swords, Dublin Airport, Ballymun, Glasnevin and City Centre to Charlemont, Co. Dublin (Metrolink)

Dear Sir/Madam.

As residents of Dublin City, we wish to submit the following observation in support of the proposed construction of the Metrolink.

For more than 20 years, the lack of adequate public transport infrastructure in Dublin has resulted in strong reliance in car-based commuting and hours of frustration for those with no other public transport option but infrequent buses trying to navigate inadequate bus lanes. The estimated 1.4m population by 2040 will dramatically further increase the need for transport to and through the city. Car-based commuting will continue to increase traffic congestion, noise emissions and air pollution and will make reaching our legal commitments of achieving net zero carbon emissions by 2050 within the tranport sector will be impossible.

The introduction of the Luas has been transformative for those lucky enough to live close to it but its limited range means it is only the saviour of the few, and of very limited use to residents in the north of the city.

It is unthinkable for a capital city as prosperous as Dublin not to have a rapid rail link between the airport and the city centre and the Metrolink proposal is a well thought through solution to this need. It also has the potential to transform transport into the city for north side residents served by the line. While the current plan does not yet guarantee a connection south from Charlemont to link with or replace the green Luas, we hope this bridge will be crossed successfully in the future.

Although it will take 10 more years for Metrolink to be constructed, we are already 30 years late in starting the project so the sooner it gets approval the better for all Dublin residents and visitors.

We therefore hope the Board sees fit to give the proposal immediate approval. The required submission fee for this observation has been paid online.
