



#### 1. Stations should have more covered bicycle parking

Bicycles can increase the catchment area of a station. Covered bicycle parking will help users be more inclined to use bicycles for the first and last mile of their trips.

#### 2. Designated bicycle parking for hire bicycles

Bicycle hire companies, such as Tier and Bleeper, can and do fill bicycle parking racks with their bikes and leave no room for private bicycles. This is already happening in Skerries. Hire bicycles should be restricted to designated parking racks at MetroLink stations to stop the hire bicycles from suppressing private bike usage by leaving no room for private bicycles at bicycle parking racks.

#### 3. Provide public toilets at all MetroLink stations


As far as I can tell, there are no plans for public toilets at any station, not even at the Glasnevin interchange with Irish Rail. The toilets in the plans all seem to be down narrow corridors away from the public areas.

#### 4. Provide more station entrances

The single entrance to most of the stations may look good on paper but the aesthetics will be lost on anyone who has to walk the length of the station in the rain or, as at Collins Avenue and O'Connell Street, wait in the rain to cross a four-lane road to be able to get to the station entrance. Even the single entrance to the Mater station is located as far as possible from the hospitals that the station is meant to serve.

#### 5. Grounds

- 5. Underground or undercover access to Airport station
  There should be underground or undercover (at the very minimum) access from the airport terminals to the MetroLink station. Walking in the rain, with luggage, and having to wait at a pedestrian crossing will be a very poor introduction to Ireland.
- 6. Plan for underground access at stations in commercial centres
  It will improve access to the stations and be more convenient for users if
  adjacent buildings can make underground connections to a concourse at the
  station. For example, Sydney Town Hall station was built without any
  connection to adjacent buildings, but has, over time, been extended with
  multiple access points.
