RE: Metrolink Railway Order

My company YMY Ltd owns the property at 8 Blessington Street.

In relation to the Metrolink Railway Order, I am writing to lodge the following observations/objections.

We own the building situated at 8 Blessington Street, Dublin 7, "Area 305 according to drawings" from Metrolink's written correspondence dated 20 September 2022.

Reference: Intended application by the National Roads Authority (operating as Transport Infrastructure Ireland) for the RAilway (MetroLink - Estruary to Charlemont via Dublin Airport) Order [2022[

1. Your plans indicated "proposed acquisition of substratum land".

Ref ML5C-U47

- i) No indication of how Metrolink intends to monitor, communicate to owners and ensure there is no structural damage/impact from the proposed works.
- II) what is the insurance/compensation should damage occur?
- 2. Environmental Impact Assessment Report
- i) How the access to the property will be impacted if at all?
- ii) Which roads will be closed when?
- iii) How the works underneath the street and around the area will impact the structural integrity of the property and what insurance we have if the house suffers damage due to the works relating to Metrolink.
- iv) what is the nearest location to 8 Blessington Street where the construction will physically break ground and where buildings will be demolished?
- v) there is reference of surveyors going in prior to work starting. Will the assessment of the potential structural impact be shared with the owners before and after the works?
- vi) What steps is Metrolink/company doing the works, taking to ensure there is no structural impact on the Georgian terrace that runs the length of Blessington Street?
- vii) What above surface structures (e.g. ventilation shafts etc) will be left long term post the Metrolink's construction?
- viii) What type of disturbance in the form of vibration and noise will be coming from underground during the construction and also when the trains are up and running?
- ix) Enabling works survey: Will the findings of that be shared with people whose property the construction may impact?
- x) Drilling and blasting: Mater station. Has there been an assessment made on the structural effects of blasting intended for the the station?

## 3. Dublin conservation

Blessington Street, Dublin 7 is a row of protected Georgian terraces.

What are the protection measures that Dublin City Council Conservation have put on to the Metrolink construction?
