

It has come to our attention that IMS have applied to An Bord Pleanala for the above licence and

We wish to air our concerns and **object** to this as we live not more than 1 km from the site.

Over the years we have endured thousands of trucks speed by our gates with no regard to the safety of ourselves, our five Children or any pedestrians or other drivers on the road.

The road is an absolute disgrace with muck and debris and even though there is a road sweeper, they seem to make the matter worse instead of better.

We are concerned and believe that the proposal has serious consequences for our environment, health and safety as the application is seeking to change the use of the quarry from infilling to integrated waste management facility, and it includes that they wish landfill 5 million tons of bottom Ash for the next 25 years.

Incinerator bottom ash is a source of leachate which is toxic to the underlying water resources and waterways and is concerning to residents farmers and local businesses.

The important and extensive groundwater aquifer in leinster lies under the site.

Landfills must be sited on deep clay in order to provide natural filtration of any escaping leachate and Hollywood quarry is situated on bar fractured rock with no natural clay protection.

Not only will water resources be at risk It will lead to a higher risk of toxic dust exposure and airborne toxin dissemination with puts our health at risk.

As Residents of the Tooman and Hollywood all ours lives we want to remain here in a safe and clean environment free from toxic fumes, ash, speeding trucks, poor road conditions etc
