

Case of ABP314964

I wish to object to replacing the current GPA waste license (W0129-02) to new Industrial Emissions License (W0129-04) to Industrials Materials Solutions Limited Partnership (IMS) which is located at Hollywood Great, Nag's Head, Naul, Co. Dublin.

My reasons for objecting to this is as follows:

1. Dumping of hazard waste i.e. bottom ash. From incinerators which may contaminate the water aquifers which are under the site and surrounding lands which my family own.
2. The dumping of Japanese knot weed.
3. The timeline of which the original license was given for completion of site was 15 years which has expired and now they work to extend to another 25 years which is unacceptable.
4. Fingal Co Council was refused a landfill only 1.5km away from this site due to aquifers and the amount of underground water, one of the biggest in all of Leinster.
5. Air quality will be at risk for operations toxic dust exposure and airborne toxin dissemination which put our health at risk
