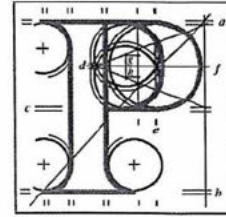



**Re : IMS Ltd Partnership. Landfill Quarry at Hollywood Great**

Dear Sir / Madam

As a local organisation we wish to object to the application by IMS for a Proposed development of a Circular Economy Campus and Integrated Waste Management Facility at the Hollywood Landfill.

Our areas of concern are as follows:

1. Negative impact on air quality in the locality impacting our members
2. Extra trucks on local rural roads and in particular passing Hedgestown school
3. Minimal engagement with local groups and members of our club who live in the vicinity
4. Predominantly the area is an agricultural area and potential contaminated water puts local produce and reputation at risk
5. We believe the most important and extensive groundwater aquifer in Leinster lies under the site and it surprises us that the authorities would put this at risk by granting IMS permission to take in incinerator bottom ash which is a source of leachate which is toxic.
6. As a young family, we feel that zero consideration has been given for the safety of our children, from any perspective but to name a few
  - safety on our roads, as they will no longer be safe on their bikes or out walking in the local area with the extra traffic from heavy dangerous vehicles.
  - Their health, as we have no doubt that the population from this waste management will enter their lungs and bodies via air, water and of course food provided by local areas growing crops in what will be polluted grounds

Overall we feel it is unacceptable that An Bord Pleanála would grant the operators permission to take in incinerator bottom ash from all waste incinerators which could potentially damage the underlying water table which is a huge source of water to the Fingal region and also potentially poison the local farming land.
