



To whom it may concern

Enclosed is our objection and fee for €50 for case mentioned below.

We wish to object to the above case for a plan to build 580 apartments, creche and 100-bed nursing home on the playing fields at the rear of St Paul's College, St Anne's Park, Raheny. This Park is public and a great amenity for the people of Dublin and beyond.

This proposal contravenes the Z15 planning regulations and will devastate the local GAA, Soccer and Rugby Clubs. We are trying to get more children to take up sports and get them outdoors, and now we have a ludicrous proposal like this in St Anne's Park.

There is no logic or common sense to this proposal. The only gain in this is for enriching a developer who doesn't care about the environment. If this gets the goahead, the developer will have made his money and the community will be left with a complete disaster in terms of the environment and traffic for the entire north side of the city. Have we not learned from our past mistakes?

I have lived all my life in Clontarf and very close to the park and if this development gets the go ahead it will be a tragedy for the park and the local community. There will be no community gain from this development; we should be enhancing the Park not destroying it.

St Anne's Park is a stone's throw from the Bull Island UNESCO Biosphere and this proposal will have an adverse effect on this as thousands of protected wintering birds use the Park as feeding grounds. It will also impact on the bat species in the park which are protected under the EU Habitats Directive.
